
Our firm represents certain Underwriter Defendants in the action referenced above and we respectfully submit this letter to request that Your Honor rescind an order recently entered by the Court granting our firm's earlier motion to withdraw as counsel to one of the Underwriter Defendants, Utendahl Capital Partners, L.P. ("Utendahl").

On July 13, 2010, our firm filed a motion to withdraw as counsel of record for Utendahl (Docket Entry No. 310) under Local Rule 1.4 based, in part, on Utendahl's liquidation and inability to pay legal fees. In the months following the filing of that motion, arrangements were reached with representatives of Utendahl and our firm was able to continue its representation of Utendahl. On November 4, 2010, we filed a notice of withdrawal of our motion to withdraw as counsel of record for Utendahl (Docket Entry No. 361). On March 24, 2011, the Court granted our initial motion to withdraw as counsel of record for Utendahl (Docket Entry No. 412) (the "March 24 Order"). Accordingly, we respectfully request that the Court rescind the March 24 Order.
